### THIS IS A COMPLETE CONTRACT FOR INDOOR BOAT STORAGE

- A. \$500 non-refundable deposit secures your space for indoor storage. Your boat must be dropped off or scheduled for drop off by October 31<sup>st</sup>, 2024 or your space will be given to the next person in line.
- B. The stored vessel and its contents will be delivered only to the owner or the owner's agents who executed this storage agreement.
- C. BC Detailing LLC DBA Professional Marine **does not insure any vessel, boat or contents in the boat**. It is the owner's responsibility to carry insurance on their vessel and goods.
- D. This agreement may be signed by the agent for BC Detailing LLC DBA Professional Marine. It must be signed by the owner of the vessel, or the owners duly authorized agent by written document.
- E. The winter storage fee is charged as a flat rate for the overall length of the boat and trailer, due at drop off. BC Detailing LLC DBA Professional Marine may add 1'- 4'+ to your model length to account for extended swim platforms, bow pulpits, trailer tongues and/or outboard motors. BC Detailing LLC DBA Professional Marine claims a lien for all storage charges, all repairs, labor and all costs necessary in the care of the vessel and/or goods. No refunds, prorations or credits are issued for shorter storage periods.
- F. **The owner shall give notice to BC Detailing LLC DBA Professional Marine of no less than ten (10) business days' notice of intent to remove from storage.**
- G. Once the boat is in storage there is no customer access to the boat until it is requested to be removed from storage. Please remove any items needed during the storage season before dropping your boat off for storage. **Any service work needed done in the off season MUST be noted at drop off to guarantee completion by spring time.** Any work requested in the spring may be pushed to the following winter.
- H. Unless the winter services are completed by BC Detailing LLC DBA Professional Marine, the owner shall be solely responsible for the winterizing or the effecting of the winterize upon the vessel, including acts as may be necessary to minimize the potential of fuel escape, oil escape, or other leakage from the systems of the vessel.
- I. BC Detailing LLC DBA Professional Marine **assumes no liability for theft, collision, fire or damage of any kind to the owners vessel or any goods stored, left or kept thereon by the owner**, unless and except when any such loss is directly and solely caused by failure of BC Detailing LLC DBA Professional Marine or its employees to exercise such care in regard to vessel and its contents as reasonably careful man would exercise under like circumstances.
- II. BC Detailing LLC DBA Professional Marine is not liable for damages which could not have been avoided by the exercise of reasonable care.
- III. Damages shall, in all events, be limited to the itemized declared value per article or item as is declared herein.
- IV. This document is not negotiable and goods will be delivered to the owner upon request and giving of receipt therefore.
- V. This agreement is not assignable
- VI. The laws of the State of Idaho shall govern this agreement.
